7. President's Report

Welcome to the Board of Trustees, Kelly Konsul

Enrollment

College in the High School enrollments increased, so the College is now down 9 percent in headcount and 15 percent in FTE against last month's report of being down 10 percent in headcount and 17 percent in FTE. C-GCC continues to outpace its sister SUNY community colleges that are still reporting steep declines of more than 20 – and in a couple of cases – 30 percent. The part-time enrollment for spring is up to 77.3% from last month's report of 76.6%.

Registration for the summer and fall 2021 semesters opens next Monday, March 22. Last Monday, Chancellor Malatras announced that SUNY plans to offer in-person classes in the fall, keeping in mind the appropriate protocols including social distancing, wearing masks, and the like. The College has a team of people working on a fall schedule that will permit more students to return to campus — but it's challenging right now given the socially-distanced classroom configurations that limit most classes to 10 students. As things will continue to change, we will continue to be nimble and make adjustments accordingly.

Operations Updates

The College continues to give COVID-19 tests every week, and since the beginning of the spring semester, only one on-campus student has tested positive. The Columbia County Department of Health continues to use Columbia-Greene as a vaccination POD (Point of Distribution), and as of last week has distributed more than 5,000 doses of the vaccine. DOH also is welcoming second-year nursing students who are helping to administer the vaccine.

Miscellany

- Thank the Trustees for adopting the Vision Statement and hearty applause to the Vision Statement Committee that included Trustee Slutzky for their very hard work.
- Greater Hudson Promise Neighborhood has included the College as a partner in a grant application to the Department of Education that will advance higher education opportunities for Hudson High School and Questar III students who live in Hudson. The grant is for five years and could be between \$20 and \$35 million.
- For Employee Recognition Day on March 5, I sent each employee a mask with a
 personal note from me thanking everyone for their amazing resolve and resilience over

8. Trustee Reports

Chairman Schneier reported:

Chairman Schneier introduced recently appointed to the Board by the Greene County Legislature, Ms. Kelly Konsul. Ms. Konsul thanked everyone for her warm welcome. Ms. Konsul is a School Counselor at the Catskill Senior High School since 2007. Trustee Konsul earned an M.S. in School Counseling from Sage Graduate School and a B.S. in Accounting from Babson College. Ms. Konsul succeeds Rick Bianchi whose term expired last year.

Each board member introduced themselves and welcomed Ms. Konsul to the Board. Chairman Schneier with a unanimous vote from the Board, will be sending a letter to Rick Bianchi to thank him for his dedication and appreciation on the behalf of the Board of Trustees.

9. Vice President's Report

Vice President for Administration, Dianne Topple reported:

We received a summary this morning of the Senate and Assembly response to the Executive Budget otherwise known as the One House Bills. This is somewhat good news as both chambers are proposing additional funding for community colleges. The Assembly is proposing a flat per FTE funding with the establishment of a 100% floor. The Senate is proposing a \$250/FTE increase and the establishment of a 98% floor. Both chambers have proposed restoring childcare funding, which would be great news for our daycare. Both chambers also propose increasing the maximum TAP award by \$1,000. We will watch over the next several weeks to see how this unfolds.

We have a finance committee meeting scheduled for April where we tentatively scheduled to have our auditors present our financial statements for fiscal year ending 8/31/2020. They just started their field work last week, so the April 19th meeting may be too soon for final financials. If it's ok with the finance committee, I would like to suggest that we keep the April meeting scheduled just in case it works out, if not, I can report out on the current year and provide an update if any on the status of the state budget and possibly schedule an additional finance committee meeting in May for the audit presentation.



Provost and Vice President of Academic Affairs, George Timmons reported:

Academic Affairs

- The Olana Partnership received a generous two-year grant directed by Kate Gubelmann to formalize a ladder of lifelong learning and engagement. This grant will support in-part a new work development and internship program in partnership with N.Y.S Parks and Columbia-Greene Community College. The academic programs participating in this grant will be Business, Environmental Studies, and the Arts.
- Since Chancellor Malatras announcement, that SUNY will resume on-campus operations in Fall 2021, the President, Provost, Division Chairs, and the core Academic Advisors have been meeting to develop a schedule that will allow the flexibility of offering on-campus, remote and asynchronous instruction while still comporting with safety guidelines. The logistics in achieving this task are very complex.
- The Columbia-Greene Community College Mission Statement Ad-Hoc Committee completed its work by submitting two mission statements for the College Senate to review. The Senate will make some revisions, and President Drummer will present it to the Board of Trustees for approval.
- The Middle States Self-Study Steering Committee met at the beginning of March to discuss the College's identified institutional priorities. The steering committee is making progress as the development of the self-study design document has begun. The seven working groups, along with our Communication and Evidence Managers, have been assigned to complete various sections of the document, which is due to Middle States at the end of the Spring semester.
- The College's Strategic Planning Committee (SPC) met to revise the language for each of the five institutional priorities. The SPC agreed additional work is required in defining student success at C-GCC. Furthermore, the SPC will need to complete the S.M.A.R.T goal for Facilities and Technical infrastructure. The updated version of the institutional priorities will be sent to the strategic planning consultant for review and comments.
- Several new program concentrations are working their way through the internal approval process before being submitted to SUNY. Maya Greene developed a communication concentration in Liberal Arts and Science (A.A.) degree. Bill Mathews, Academic Advisor in cooperation with the Natural Science Division, Liberal Arts and Science/Health Science Concentrations.

Many of the concentrations will be made up of existing courses requiring minimal investment. These concentrations prepare students for transfer into a variety of health science bachelor's degree programs. Intensive advisement is provided to help students make intelligent, reality-based transfer and career decisions.



Student Services Update

- The Graduation Committee has recommended and, with the President's approval, to conduct a drive-by graduation, Caravan Commencement. The graduation will include graduates from the classes of 2020 and 2021. The location will be the parking lot of PAC Building, and the committee is working on the logistics.
- I am excited to report the partnership between CGCC and Columbia County Mental Health Center to offer on-campus mental health services for students again. The county will provide the College with one Licensed Social Worker to provide up 350 hours for the academic year. The start date is to be determined.
- The Office of Accessibility Services has filled a vacant position, left open upon the retirement of a long-term employee, to gear up for the Fall 2021 semester. The vacancy has been filled by Gavin Barker, a part-time, 10-month, Technical Assistant for The Office of Accessibility Services. The part-time position supports students with disabilities and the Faculty to ensure access to all learning materials for students with disabilities.
- Welcome to Katie Davis. Katie joined us this week as the Assistant Director of Community Engagement and Professional Development. Please join me in welcoming her to the CGCC team.
- The College has onboarded Joni Groll, temporarily to assist Laura Sangi, Director of Health Services, due to the additional work associated with the mandatory SUNY COVID testing.
