# 7. President's Report

## Enrollment

Registration for the summer and fall 2021 semesters opened on Monday, March 22. Kudos to an amazing team of people who developed a fall schedule that will permit more students to return to campus – but also provides the opportunity for virtual learning through online, remote, and hybrid options. Advisors tell me that currently enrolled students are showing a preference for virtual modalities, and we imagine that entering students will choose in-person classes. Summer enrollment is looking very positive – as of this morning, up 47 in headcount.

#### **Operations Updates**

The College administers COVID-19 tests every week to all on-campus students and employees, and the Columbia County Department of Health continues to use Columbia-Greene as a vaccination POD (Point of Distribution). Since January 3, DOH has distributed more than 10,000 doses of the vaccine on campus. Our second-year nursing students are still helping to administer the vaccine.

### **Awards and Recognitions**

Congratulations to our Student Trustee, Emily Kratz, for receiving the Chancellor's Award for Excellence! This is the highest honor SUNY bestows every year, and Emily, we could not be prouder of you and your accomplishments during your time at Columbia-Greene. Provost and Vice President of Academic Affairs, George Timmons reported: **Academic Affairs** 

• The College is in the process of searching for a Dean of Academic Affairs, Dean of Student Development, Director of Institutional Research and Effectiveness, Faculty for Construction Technology and Help Desk Technician. The search committees were finalized and or actively reviewing applications. The expectation is to have all positions filled for the start of the Fall 2021 semester.



• The Strategic Planning Committee (SPC) held a 3-hour workshop with the Strategic Planning consultant to finalize a draft of the institutional priorities in a S.M.A.R.T goal format. The SPC will wordsmith the final priorities and work with key stakeholders to develop tactics and goals to achieve institutional priorities.

• I would like to recognize Dan Connor, Professor of Arts & Humanities work of a nuclear plant image, that was used during a recent 60-Minutes interview with Bill Gates. Please join me in saying "Congratulations, Dan!" on his recent accomplishment.

• The Middle States Self-Study Steering Committee met at the beginning of March to discuss the College's identified institutional priorities. The steering committee is making progress as the development of the self-study design document has begun. The seven working groups, along with our Communication and Evidence Managers, have been assigned to complete various sections of the document, which is due to the Middle States Commission at the end of the Spring semester.

• CITHS – spring enrollment is at 514. The CITHS Summer program is being worked on and new courses will be added. Renowned Author – Taylor Mali will be presenting on May 4th to CITHS stakeholders. Also, invited are members of the C-GCC campus community.

• President Drummer, Provost Timmons, and Dawn Wrigley, Chair of Nursing Division met with the leadership team of Columbia Memorial Hospital to explore ways to strengthen our partnerships and better serve the community.

• The College has received laptops and docking stations, and two monitors for all faculty, staff, and administrators. The new equipment will increase the mobility and productivity of all employees. CIS will be distributing this equipment over the coming weeks. CIS is also actively working on the implementation of the new phone and wi-fi system. **Student Services Update** 

• The Graduation Committee continues to make significant progress with the planning for the Caravan Commencement. A dress rehearsal is scheduled for Thursday, May 13, 2021. This year's commencement will have approximately 90 students participating.

• C-GCC continues to make forward strides in our effort to recruit students. We have recently partnered with Liaison. Liaison provides an easy-to-use, configurable, cloud-based platform to identify, recruit, admit and enroll best-fit students. Specifically, the software allows for a centralized application and enrollment solution that includes marketing and CRM.

• Professor Stacey Hills is partnering with the Office of Career Success to present a series of "Success in Business" (virtual) seminars featuring local professionals. Amy Bonville from Columbia Tent was the first featured speaker and presented a case study about upscaling businesses. Also, Bryanna Mehling, an Employee and Organizational Development Manager, will be sharing her experiences in the Enterprise Manager Trainee program and finding the right "culture match" during a job search.
