Commencement

Enrollment

Today is the opening of the Summer I 2021 semester. The enrollment for Summer is up by 48 students! Matt Green, Assistant Dean of Enrollment Management will be looking at enrollment for the fall after our July break.

Operations Updates

The College is administering COVID-19 tests every week to all on-campus employees. The Columbia County Department of Health continues to use the College as a vaccination Point of Distribution. Since January 3, DOH has distributed more than 15,000 doses of the vaccine on campus. Our second-year nursing students are still helping to administer the vaccine.

Awards and Recognitions

The College celebrated the students from Hudson High School, Cairo-Durham High School, COARC, and other advocacy programs who graduated from the Community First program on May 4. Applause to the students in the Human Services program who serve as mentors and to Dawn DeFino who ten years ago identified the need for a learning and collaborative partnership to celebrate, motivate, and empower students with different abilities.

Dawn-Marie Blasl organized a dynamic event to celebrate the College in the High School teachers and guidance counselors. Taylor Mali, the celebrated author of "What Teachers Make: In Praise of the Greatest Job in the World", was the keynote speaker.

Columbia-Greene's Chi Gamma Chi chapter of Alpha Sigma Lambda, the honor society for post-traditional students, inducted four graduates who have distinguished themselves with scholarship, leadership, and community service. Alpha Sigma Lambda, whose motto is "First in Scholarship and Leadership", is the oldest and largest national honor society for post-traditional students.

Dr. Bonfiglio will be meeting with the College community via zoom on May 25, 2021.
- I want to thank Laura Sangi, Director of Health Services, and Lori Mashaw, Associate of Academic Affairs, for organizing the logistics regarding the Covid-19 testing for oncampus final exams. Also, thank you to Mary Garafalo, Christina Judisky, and Adrienne Tyrell for their assistance in conducting the test in an efficient manner and providing our students with a positive experience.
- President Drummer, Provost Timmons, Joan Koweek, and Bill Mathews had a preliminary meeting with Kirk Kneller, President of Kneller Insurance, to discuss the plausibility of adding insurance and finance micro-credentials or certificates to our academic portfolio. A second meeting will be held in the coming weeks to review recommended programs and next steps.
- Sheriff Bartlett, Columbia County, and Sheriff Kusminsky, Greene County, will be on campus on June 29, 2021, to participate in a meeting to discuss the Criminal Justice Program's Use of Force Simulator and how it will serve as a training tool for local law enforcement. - Congratulations to Dr. Melissa Boles, Assistant Professor, Biological Sciences, for being named Lumen Circles Fellow. Lumen Circles uses virtual learning communities to provide professional development to faculty aimed at refining student-centered teaching skills.

Clint's employment began at Columbia-Greene Community College on September 1, 1978, as an Instructor of Data Processing.
