Professor William DeLuca presented a Powerpoint presentation on the Police Basic Training Certificate. Professor DeLuca has been working with the CGCC Criminal Justice Program, Greene County Sheriff's Office, Hudson Police Department and the Columbia County Sheriff's Office, in the development of this certificate.

This 30-credit certificate program will enable students to complete Phase I of the Basic Course for Police Officers. Phase II of the Basic Course for Police Officers is presented once a graduate has secured police employment.



This certificate can be tied into our Individual Studies A.O.S. degree, with the first year of study taking courses that support a student's professional development and preparing them for Police Basic Training, which would constitute the second year of the program. Graduates of the Police Basic Training Program, having completed a significant portion of the required police training before being hired, allows police agencies to assign them to field studies without supervision much more quickly than candidates without this credential.

## 8. President's Report

- President Drummer introduced Maureen Sager, Director of Marketing and Communications. She also, thanked Drew Ledoux for his continued help curating the College's social media platforms Facebook, Instagram, and Twitter. Searches are underway for the Director of College in the High School and Director of Student Success.
- The IDEA Committee has been quite active since the beginning of the semester. In celebration of Black History Month, the Committee hosted a panel discussion on the topic, "Black Leadership: A Local Perspective". Panelists included Dr. Ronel Cook, Superintendent of the Catskill Central School District; the Honorable Kamal Johnson, CoGreene alumnus and Mayor of the City of Hudson; and Elena Mosley, Executive Director of Operation Unite. Rachel Arnwine, a recent Columbia-Greene graduate and now a member of the Admissions Office, facilitated the event.

Last Tuesday, the Committee presented "Courageous, Critical, and Curious Conversations: First Name and Personal Pronouns", a program that fostered great discussion and raised awareness about an important component of advancing cultural competency at the College.

- In the middle of February, a number of the campus community members attended the annual convening for Achieving the Dream institutions. They met with the College's ATD Coaches to discuss the Action Plan for the spring semester that focuses on two goals:
  - o Strengthening support for adult students, including online learners; and
  - Strengthening early intervention strategies for academically vulnerable students.

Many thanks to the ATD Core Team Co-Chairs Matthew Kenny and Drew Ledoux for their tireless leadership. Also, thank you to the ATD Committee members for their continued commitment and enthusiasm to help students stay on track and achieve their goals.

This is budget season and President Drummer has been busy garnering support from our elected officials, Congressman Delgado and State Senators Michelle Hinchey and Daphne Jordan. The top priority is to establish the floor at 100 percent of the flat dollar



amount allocated to community colleges in 2019-2020 (before the pandemic), along with a three-to-five-year commitment to this funding for predictability, proper planning, and codification in state law.

In addition, the community colleges are requesting \$30 million in workforce investment to support "just in time" training programs that meet workforce needs in high-demand fields such as health care and information technology.

At the beginning of the month, Senator Chuck Schumer met with the SUNY Community College Presidents and provided updates on his advocacy for our sector including an Appropriations Bill that includes a provision to increase Pell Grants by \$400. He also is optimistic about the future of the "Make It In America" legislation that allocates \$10 billion for new technology hubs to support workforce development.

• In other exciting news, Senator Hinchey is partnering with Greene County to provide \$10a0,000 from a State and Municipal (SAM) Facilities Grant to upgrade the Environmental Field Station at the Cohotate Preserve. The hope is that the building potentially can be used year-round instead of only in the summer. President Drummer, Provost Timmons and Dr. Rebecca Pinder, attended an initial meeting last week with several Greene County Legislators and County Officials to discuss the project.

# 9. Trustee Report

## Student Trustee, Laura Best-Macia reported:

#### Athletics

- Mike Esslie will join C-GCC as Women's Head Soccer Coach. Coach Esslie, of Greene County, is a seasoned soccer coach having spent many years leading local youth teams. He is a welcomed addition as his experience and community connections will bolster CGCC's Soccer Program.
- The Baseball Team is preparing for the spring season. The first game of the season is scheduled for Sunday, March 13<sup>th</sup>, against Westchester Community College.
- All teams are actively recruiting for Fall 2022.

### **Student Activities**

#### Criminal Justice Club

The Criminal Justice Club was created to provide students an opportunity to interact and form connections with other criminal justice students and faculty outside of the classroom. They hold bi-weekly meetings during the student activity period. Club members engage in team-building activities, such as nature walks, fundraising, and community service. They have assisted with the preparation of Thanksgiving dinners for Community Action of Greene County.



The Criminal Justice Club students receive an in-depth education about the many careers available in criminal justice. Also, they learn the hiring process and the issues criminal justice practitioners face working in the field over the last several years, including the pandemic.

There has been a diverse range of 15 participating representatives serving as guest speakers and/or providing opportunities for students to visit their facilities. They have had local law enforcement from the Greene and Columbia County Sheriff's Offices, the Department of Environmental Conversation and the FBI.

The advisors, Frankie Beaver-Timmons and William DeLuca, and club members, are looking forward to increasing their club membership post-COVID. They report they are thrilled that over the past two years they've held meetings and invited guests to speak to their students remotely, in-person and in hybrid modalities. Along with aspiring to increase membership over the next year, the club will seek out and participate in more community services.

### 10. Vice President's Report

a. Provost and Senior Vice President for Academic and Student Affairs, George Timmons reported:

#### **Academic Affairs**

- Due to upcoming retirements, we have multiple faculty openings, all to begin September 1, 2022. The vacancies include the Nursing, Criminal Justice, Chemistry, Computer Science, Cyber Security, and English.
- The College submitted a High Needs Nursing Proposal- we received an email from SUNY notifying the college that we receive \$88,200 to support equipment and staffing needs.
- We held our first kickoff Brightspace meeting- Associate Professor Nicole Childrose and Joe Scampoli are co-chairs of the Distance Learning Committee. This committee will play a significant role in leading the college-wide Blackboard migration and advancing progress toward the Brightspace Conversion.
- MS Update-Middle States has suggested a team chair for our evaluation visit in Spring 2023. We are waiting for the invitation to be accepted. Once confirmed, we will make arrangements for the preliminary visit with the chair to discuss the College's self-study report.
- Individual Studies A.S.- A revision to our individual studies A.S. program has been sent to SUNY and State Ed for review. The program will now be offered in a fully online format with two new concentration options in Business and Social Science.
- Climate change C-GCC is participating in the 2022 Worldwide Climate/Justice
  Teach-In, scheduled for March 30, 2022. Organized by Bard College's Graduate
  Program in Sustanability, institutions of higher education, K-12 organizations, and
  faith communities will mobilize to raise awareness about climate-related issues and
  have a dialogue about solutions. C-GCC will host a virtual speaking engagement for
  the campus and the wider community. Program details will be advertised in the
  coming days.



Cairo Library - the College is having conversations with Cairo Library to explore
offering micro-credentials and personal enrichment classes. To identify the
appropriate offerings, a brief survey has been developed and will be disseminated
to members of the Greene County community.

### **Student Services Update**

• Achieving the Dream

C-GCC submitted its ATD Action Plan in early February. The plan detailed progress made over the past year and detailed strategies aimed at reducing barriers for the College's underserved students over the course of the 2021-2024 funding cycle.

Members of the ATD Core Team were among thousands to attend the DREAM 2022 Conference last week. DREAM 2022 centered on five key themes that represent opportunities to effect meaningful change in our communities, including:

- Building stronger pathways to and through postsecondary education
- o Adopting a holistic, equity-focused approach to community vitality
- Eliminating systemic barriers to student success
- o Fostering a sense of belonging through teaching and learning excellence
- Leveraging data and analytics for institutional and community well-being

Accessibility Services

Marisa Hayes has been hired as part-time Technical Assistant for the Office of Accessibility Services. A graduate from SUNY Albany, Marisa is now enrolled in an M.S. in MLIS & Archival Studies with Louisiana State University (online). Marisa has spent the last few years as a substitute teacher and is passionate about supporting students with various learning styles.

b. Vice President of Administration and Chief Financial Officer, Dianne Topple reported: We have started development of our 2022-2023 budget. Department and Division leaders are due to submit their budget requests today.

Vice President Topple is waiting on the final issue of our audited financial statements, which she expects to be released this week. As soon as she receives the final documents, she will send those out along with a spreadsheet showing the breakdown of expenditures by category and a list of items included in each category as requested at the finance meeting.

At next months' finance committee meeting, she plans to share our expenditures to date with respect to the federal stimulus funds.
